

ORDINANCE NUMBER 182

BENTON COUNTY, MINNESOTA

WHEREAS, on December 30, 1987, Edward & Margaret Wilson made application for an amendment of Ordinance Number 114 (the Benton County Zoning Map), and any other ordinance, if any, amending Ordinance Number 114, as to the tract of property described below, requesting that the property hereinafter described be rezoned from "R-1" Single Family Residential to "A-2" Agriculture; and

WHEREAS, on January 5, 1988, a notice of public hearings was published in the official newspaper and mailed to the governing bodies of all towns and municipalities located within Benton County; and

WHEREAS, on January 21, 1988, the planning commission held a public hearing thereon and recommended same to the Benton County Board of Commissioners for approval and passage; and

WHEREAS, on February 4, 1988, the Board of County Commissioners held a public hearing thereon and approved the proposed zoning amendment,

NOW, THEREFORE, BE IT RESOLVED by the County Board of Benton County, Minnesota, that Ordinance Number 114 (the Benton County Zoning Map), and any other ordinance, if any, amending Ordinance Number 114, be and hereby is amended as follows, to-wit:

The following described property situated in the County of Benton and State of Minnesota is zoned "A-2" Agriculture:

That part of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Nine (9), Township Thirty-seven (37) North, Range Thirty-one (31) West, Watab Township, Benton County, Minnesota, lying West of the following described line: Commencing at the northeast corner of said NE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence North 89°42'06" West along the North line thereof for 650.44 feet to the point of beginning of the line to be described; thence South 17°12'24" West 480.21 feet; thence South 4°34'45" West to the South line of the North Half of the Southwest Quarter (N $\frac{1}{2}$ of SW $\frac{1}{4}$), and there terminating.


BE IT FURTHER ORDAINED that this Ordinance be added to Appendix IV of Ordinance Number 113, the Benton County Development Code.
