

ORDINANCE NUMBER 225

BENTON COUNTY, MINNESOTA

WHEREAS, on December 30, 1992, Leonard Herbst & Morton Buildings, Inc. made application for an amendment of Ordinance Number 185 (Benton County Development Code), and any other ordinance, if any, amending Ordinance Number 185, and Ordinance Number 193 (Benton County Zoning Map), and any other ordinance, if any, amending Ordinance Number 193, requesting that the property hereinafter described be rezoned from "A-1" Agriculture to "B" Business; and

WHEREAS, on January 26, 1993, a Notice of Public Hearings and Intent to Amend Benton County Development Code and Zoning Map was published in the official newspaper and mailed to the governing bodies of all towns and municipalities located within Benton County; and

WHEREAS, on February 11, 1993, the planning commisison held a public hearing thereon and recommended to the Benton County Board of Commissioners that said application be approved; and

WHEREAS, on February 16, 1993, the Board of County Commissioners held a public hearing thereon and approved the proposed zoning amendment,

NOW, THEREFORE, BE IT ORDAINED by the County Board of Benton County, Minnesota, that Ordinance Number 193 (Benton County Zoning Map), and any other ordinance, if any, amending Ordinance Number 193, be and hereby is amended as follows, to-wit:


The following described property situated in the County of Benton and State of Minnesota is zoned "B" Business:

The South 280.5 feet of the East 466.5 feet of the Southeast Quarter of the Southwest Quarter (SE1/4 of SW1/4), Section Twenty-three (23), less right-of-way of State Highways #25 and #95, also the North 350 feet of the East 650 feet of the Northeast Quarter of the Northwest Quarter (NE1/4 of NW1/4), Section Twenty-six (26), less right-of-way of State Highways #25 and #95, all in Township Thirty-six (36) North, Range Twenty-nine (29) West, St. George Township, Benton County, Minnesota.

BE IT FURTHER ORDAINED that this Ordinance be added to Appendix I of Ordinance Number 185 (Benton County Development Code), and any other ordinance, if any, amending Ordinance Number 185.
