

Statement of Evidence:

N $\frac{1}{4}$  CORNER OF SECTION 25, TOWNSHIP 37, RANGE 29

1) A post was set at a midpoint distance between the NW and NE corners of Sec. 25 by U.S. Government Surveyors in July of 1855. No evidence of the post or Bearing trees remain.

2) During a survey that was done by me in the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Sec. 25 in Sept. of 1990 it was required that this corner be reestablished. This position was set at an equal distance between the NE and NW corners of Sec. 25 which had previously been reestablished and was set on the existing fence line occupation extending to the East and West of this corner. There is a fence corner at the NW corner of the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Sec. 25 that fits very well with the position of this N $\frac{1}{4}$  corner as set by me.
